16. Bachelor's/Master's/PhD studies: identification data for the certificate/diploma, series and number of the study document, domain, study programme, class, average score, title and coordinator of the thesis/dissertation;
17. Data for budget-fee distribution of students.

I declare that I agree that the processing of personal data provided by the undersigned will take place between **27 June** and **1 November 2022** for the following purposes: **ADMISSION EXAMINATION**.

I understand and agree that my personal data will be disclosed to the following categories of recipients: **Ministry of Education**.

I am aware that I can exercise all my rights provided by EU Regulation 2016/679 as follows:

The right to information: the right to be informed about the identity of the controller, the purpose for which the data are processed, the recipients or categories of recipients of the data, the period for which the data will be stored or the criteria used to establish this period, the existence of rights provided by EU Regulation 2016/679 for the person concerned and the conditions under which they can be exercised.

The right of access to data: the right to obtain confirmation from the controller whether or not one's personal data are being processed and, if so, access to such data and information as provided by law.

The right to rectify data: the right to obtain from the controller, without undue delay, the rectification of inaccurate personal data.

The right to deletion of data: the right to obtain from the controller, without undue delay, the deletion of personal data under the specific conditions provided by law.

The right to restrict the processing: the right to obtain from the controller the restriction of the processing in the specific cases provided by law.

The right to data portability: the right to receive personal data that have been provided to the controller in a structured, commonly used and automatically readable format and the right to transmit these data to another controller.

The right to opposition: the right of opposing at any time, for reasons related to a particular situation, to the processing or profiling of personal data, unless the controller demonstrates the existence of legitimate and compelling reasons that justify the processing and are prevailing over the interests, rights and freedoms of the person concerned or that the purpose is to establish, exercise or defend a right in court.

The right to withdraw consent at any time, without prejudice to the lawfulness of the processing carried out on the basis of the consent before its withdrawal.

The right to appeal to the National Supervisory Authority for the Processing of Personal Data or the court for the defence of any rights that have been violated, as guaranteed by EU Regulation 2016/679.

All these rights can be exercised by sending a written request, which will be dated and signed and will include the requests made and their reasons, to UNEFS at the address: Bucharest, 140 Constantin Noica Street, Sector 6, Zip Code 060057, e-mail: secretariat@unefs.ro.

I declare that I did not provide false information in the documents presented and, knowing the provisions of art. 326 of the Criminal Code, I assume responsibility for the personal data provided, ensuring that they are current, real, correct and complete.
